

## PAPER SUBMISSION GUIDELINES

1. The structure of the paper must include: title of the paper, first name, patronymic (if any), and surname of the author, his/her academic rank and degree, e-mail address, an abstract of the paper, not less than 100 words in length (it must not contain phrases already used in the title of the paper), keywords (more than 11 terms, without repeating those already used in the title and/or abstract of the paper). All this data is supplied first in Russian, then in English, followed by the text of the paper in the Russian or (as agreed upon with the editorial office) English language.

2. It is recommended that the paper should have the following layout: introduction (the state of the problem), goal of the research, research materials and methods, results of the research and their discussion, conclusions, and list of references. The paper must contain the results of research conducted by the author him/herself and have scientific novelty.

3. A separate file is attached to the paper containing information about the author: first name, patronymic (if any), and surname, year of birth (not published), position and place of employment or study (without abbreviations), academic rank and degree, e-mail address and phone number (not published). The author may indicate the area of his research interests.

To be accepted for publication, the paper should contain not less than 18'000 and not more than 25'000 characters without the length of the References section.  
We do not publish short notes.

4. The paper is prepared using any word processor preferred by the author. Figures used in the paper are attached as separate .jpg or .tif files with a resolution not less than 300 dpi to make it possible to print them in their original size in the publication. The use of colour is encouraged. The names of files containing figures should be the same as in the text of the paper.

5. At the end of the paper there is a list of references in Russian and/or foreign languages which should contain sources having an explicit author (authors). The list of references in Russian should be drawn up in accordance with the Government Standard GOST R 7.0.5.—2008. This list is repeated in Latin transliteration: sources in Russian are transliterated (*not translated*), sources in foreign languages are repeated without change. This transliteration is made by the editors, here it is mentioned for the information of the authors. The list of references should contain information about all publications mentioned in the paper but should not include works not referenced in the paper. References to laws, government standards (GOSTs), instructions and other sources having no explicit author, as well as to manuals, textbooks, study guides, &c, should be given (if really necessary) in the footnotes (numbered sequentially in the paper) or in the text of the paper.

It should be understood that the list of references contains, in fact, sources with which the author argues or conducts an imaginary dialogue. There is no sense in going into discussion with a law, government standard, or an author of a textbook.

It is strongly recommended to follow the template which can be found in the section "For the Authors", "Paper Layout Template".

Not less than a half of the sources should be included in one of the following leading citation indices:

- Russian Scientific Citation Index (RSCI / ВИИЛ): <http://elibrary.ru> ;
- Web of Science: <http://ip-science.thomsonreuters.com/mjl> ;
- Scopus: <http://www.scimagojr.com/journalsearch.php> ;

When choosing a source, it is recommended to take into account its open availability. It is desirable that the sources used should be accessible via the Internet.

Bibliographic references in the text of the paper should be indicated in square brackets, in accordance with their numbers in the list of references. When a reference is made to a specific fragment of the source, the number and page are specified, separated by a comma, like this: [10, p. 81].

6. All papers, irrespective of the author's academic degree, undergo reviewing and an originality check.

7. An electronic version of the paper should be submitted by e-mail to the address [monitorlaw@yandex.ru](mailto:monitorlaw@yandex.ru).

Sending a paper to the editorial office means the author's consent to transfer his/her rights to the paper if it is published.

8. Papers sent to the editorial office not in compliance with these Paper Submission Guidelines shall not be accepted. The editorial office reserves the right to select papers. The paper may be sent to the author for revision or rejected on formal as well as scientific criteria. Received manuscripts are not returned to the authors. It is not allowed to send papers to the editorial office which have already been published and/or accepted for publication by any other journal.
